Does Oman need an environmental impact assessment (EIA)?

In accordance with national legislation (MD 48/2017),the Project is classified as a Category 'A' activity and requires an Environmental Impact Assessment (EIA). The EIA A (also known as ESIA A) received approval from Oman's Environmental Authority in July 2024,along with the associated permit conditions.

How does the north Oman solar PV project support the economy?

It mainly supports the economy by sourcing services from local businessesrather than providing direct jobs. The area of influence (AoI) for the North Oman Solar PV Project extends 15 km around the site,located in the Ad Dakhiliyah Governorate,specifically in the Wilayat of Adam.

What is environmental protection in Oman?

Environmental protection within Oman is primarily governed by the "Law for the Conservation of the Environment and the Prevention of Pollution" (Royal Decree 114/2001) which is managed by the Environmental Authority (EA),formerly known as the Ministry of Environment and Climate Affairs (MECA).

Who is supplying electricity to Petroleum Development Oman (PDO)?

The electricity produced will be supplied to Petroleum Development Oman LLC (PDO). To connect the power to PDO's grid, a 132 kV aerial transmission line, about 5 km long, will link the Project's substation to PDO's existing Saih Nuhydah Depletion Compression substation.
