Does Huawei have a trade restriction?

In 2019, the Department of Justice (DOJ) charged Huawei and its officials with financial fraud and sanctions violations. The Department of Commerce (DOC) subsequently added Huawei to the Entity List--a trade restriction list published by DOC's Bureau of Industry and Security--requiring companies to obtain a license to export goods to Huawei.

Why was Huawei able to expand globally?

Huawei asserts it was able to expand globally due to investments in R&D, improved products, low pricing, and customized service--an assertion supported by some carriers. <sup>72</sup> However, many analysts attribute some of Huawei's growth to Chinese government assistance.

Can US agencies use Huawei equipment?

In 2018, it prohibited U.S. agencies from obtaining equipment, systems, and services that use Huawei equipment or services as a substantial or critical component, and prohibited the use of federal grants and loans for Huawei products.

Is Huawei a Chinese company?

Huawei Technologies Co., Ltd., is a China-based company that designs, manufactures, and sells telecommunications network equipment and devices. Founded in 1987, the company has grown from a small reseller of imported telephone switches into a multinational conglomerate with revenues of \$138 billion in 2020 and a presence in over 170 countries.
