Who controls the energy sector in Lesotho?

There are other Ministries or agencies with overarching influence over the energy sector: Ministry of Development Planning; Ministry of Finance; Ministry of Mining; Ministry of Public Works and Transport; Water Commission; and Lesotho Revenue Authority. Lesotho Electricity Corporation (LEC) generates, transmits, and distributes electricity.

The electricity supply industry in Lesotho is dominated by two state owned entities, namely the Lesotho Electricity Company (LEC), which is the monopoly transmitter, distributor and supplier of electricity, and the Lesotho Highlands Development Authority (LHDA), which is the main generator of electricity through its Muela Hydro Power Station.
