What is the telecommunications regulator of Cambodia (TRC)?

The Telecommunications Regulator of Cambodia (TRC) oversees the certification and type approval of telecommunications and radio equipment in Cambodia. TRC ensures that products meet the technical standards necessary for safe and effective operation within the country's communication network.

Do telecommunications and radio frequency devices need type approval in Cambodia?

All telecommunications and radio frequency devices intended for sale or use in Cambodia require type approval. This includes, but is not limited to: To apply for type approval, applicants need to provide: This process involves a series of steps that confirm a device's compliance with local regulatory requirements.

What is the import permit & type approval of telecommunication equipment?

The import permit and type approval of telecommunication equipment or product are administered by the Law on Telecommunications promulgated on 17 December 2015.

What are the administrative procedures for importing equipment into Cambodia?

There are no other administrative procedures apart from the system described above. However, to be eligible to apply for the import permit (under the Sub Decree No. 370), a firm must hold a QA certificate and must prove that those particular models of equipment to be imported into the Kingdom of Cambodia have TA certificate issued by TRC.
